Overdose Death Disparities Widen as Pandemic Rages On

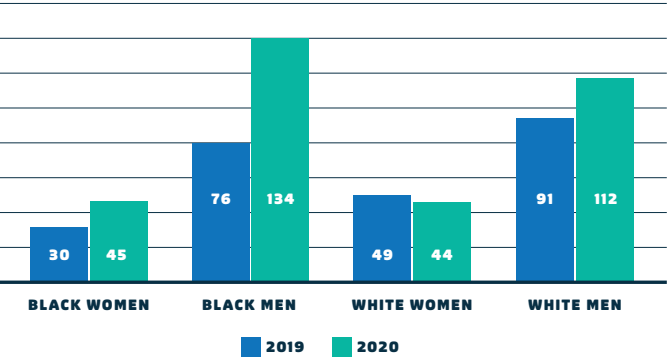

As the COVID-19 global health pandemic continues to impact every part of our lives, overdose deaths have skyrocketed. Between January 2020 and the end of June, 165 individuals in the City of St. Louis lost their lives to an overdose, representing a 36% increase from the same period in 2019. But those deaths are not impacting white and Black residents proportionally. In fact, according to preliminary data released

by the Missouri Institute for Mental Health, overdose death rates for the first half of 2020 among Black residents have increased by 54% while increasing among white residents by just 11%.

This alarming data begs us to do more.

At PreventEd, we are implementing strategic ways to better reach Black communities in several ways: partnering with *Williams and Associates* to distribute naloxone in high risk communities; working with local probation and parole departments and diversion offices to provide assessments and referrals; offering our adolescent early intervention program, GuidEd, at no-cost when a young person is struggling with substance use; and distributing Narcan at COVID testing sites.

But more must be done.

It is imperative that we examine the root causes and tackle the inequity further upstream. With this in mind, PreventEd is

expanding our advocacy priorities to include items that will protect the health of our *entire* community.

1. We must tear down barriers that prevent people from getting the help they need and further explore strategies that will save lives. Sample strategies include sterile syringe access and expansion of addiction medicine into the primary health care setting. Moreover, so long as individuals at high risk of witnessing or experiencing an overdose have a deep distrust of 911 responses, we must expand access to naloxone and breathing masks into churches and other community settings.

2. We must advocate for rapid implementation and full funding of Medicaid Expansion. Medicaid Expansion will increase access to affordable treatment and medication, helping to reduce the racial disparities that exist due to socio-economic and employment factors.

3. We must implement policies to ensure that those who are arrested solely on possession of a controlled substance or paraphernalia be processed and released under their own recognizance as quickly as possible. Individuals detained or jailed solely for the possession of a controlled substance or paraphernalia **do not** pose a threat to their community. However, spending time in a detainment facility dramatically increases the likelihood of contracting and then spreading COVID-19.

4. We must consider behavioral health recommendations to minimize the interruption of substance use and other mental health care before any movement of unhoused people can occur.

This is not an exhaustive list of ways to remedy the increase in overdose deaths. Rather, these are recommended next steps in a long journey to address systemic racism in our region.

The current surge in overdose deaths particularly among our Black residents is a cause for serious alarm and should serve as a wake-up call to service providers, politicians and corporations. All options must be on the table to remedy this dire situation, as every data point represented is someone's mother, father, brother, sister, cousin, or child.

Broadening Support in Franklin County

At the end of the one year rural opioid planning grant awarded in 2019 for Franklin County, PreventEd was awarded a complementary Implementation grant to put our plans into action. We are so excited to see our goals come to fruition. Based on our collaborative planning with our Franklin County Consortium members and countywide partners over the last year, our future implementation plans include four major components:

- 1. Increasing Recovery Support Services through Certified Peer Specialists (CPS) in Franklin County,
- 2. Reducing stigma attached to having substance use disorder(s) by increasing public awareness,
- 3. Increasing training and education of educational staff, general community, and First Responders (efforts which

will increase awareness of available treatment and prevention services and resources in Franklin County).

4. Increasing training and education of medical treatment providers to increase the number of buprenorphine waived providers, thereby increasing clients/patients receiving Medication Assisted Treatment in Franklin County.

This funding opportunity not only allows us to lean further into substance use prevention and education, but also further support first responders, medical providers, and the recovery community. With the opportunities presented by this grant, we are seeking to bridge the gaps between prevention, treatment, first response, and recovery in Franklin County.

Bringing Happier Hours to 2021

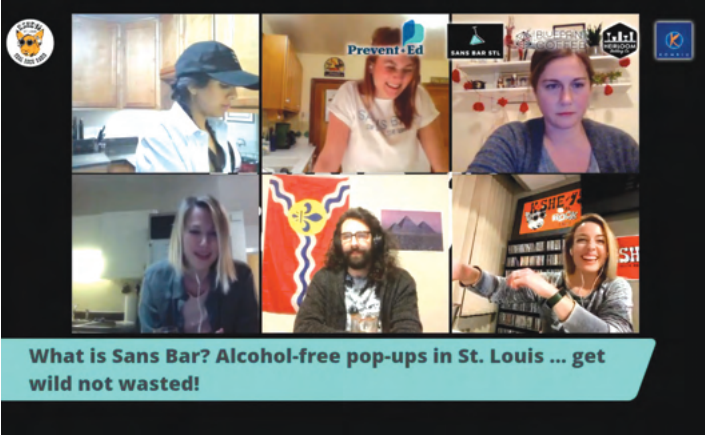

PIVOT

Since mid-march the Prevention Education department has acquired several slogans that have gotten us through the past few months. "PIVOT," "go with the flow," and "we can and we will" are just a few, yet each defines what the Prevention Education department has endured through COVID.

March 17th marked the last day educators provided programs in a "normal" classroom setting. Since then, the department has shifted to almost 100% virtual. Our educators are well versed in over 30 programs typically delivered in an in-person classroom setting. As last semester ended with schools closed and students learning virtually, we knew we needed to pivot our programs—fast.

In about 3 months, a group of educators evaluated which programs were delivered most often, and narrowed those down to 16 curricula. Each included 4-14 scripts to pivot. This was no easy feat, but before we knew it, we had virtual lessons, interactive activities, virtual surveys and books, pre-recorded activities, and even our own recording studio. Our programs had officially entered the 21st century!

Now that we had lessons ready, we needed training. Our educators are some of the best teachers I've had the privilege of working with. We have teachers from a variety of backgrounds, "Teacher of the Year" teachers, and teachers whose students write books dedicated to them. Virtual teaching, though, provided challenges and fears none of us were prepared for.

Saying Goodbye – A Special Thank You
In late November 2020, PreventEd lost a long-time community supporter, Dr. Evelyn Irving. Dr. Irving, a certified psychologist, was an inaugural and long-serving member of the St. Louis County Children's Service Fund Board of Directors. Dr. Irving specialized in Family & Children's Psychological Counseling and we are forever grateful for her support of our programs. We could always count on her attendance at Coalition on Addictions meetings and other PreventEd community events throughout the year. She will be missed.

To become more comfortable with the new technology we did dress rehearsals. Each educator picked a lesson to present to a group of peers who would act as their students. Between the "can you see my screen," "you're still on mute," and all of the cute babies and animals that made guest appearances, each educator successfully mastered teaching virtually.

As we've been in virtual classrooms for a full semester, we feel like pros, who only occasionally leave ourselves on mute. We've received glowing feedback from teachers who are thrilled we're still providing lessons to students who need them more than ever. One teacher even said it felt like our educator was in the classroom with her students and it didn't feel virtual at all.

Although each educator is chomping at the bit to get back in the classroom, our programs continue to maintain their integrity, and each educator continues to make connections with every student they work with. We will always provide quality programs, factual information regarding substances, and make lasting impressions on the students we teach, no matter the platform.
